

REGISTRATION RULES

1. GENERAL INSTRUCTIONS

- 1.1. When interpreting this registration form and the Published Rules governing registration, the following standard terms shall apply:

The OSA:	is the Ontario Soccer Association.
Published Rules:	are By-Laws, Rules, Regulations, Policies, Procedures, or Laws adopted by the OSA or any organization under whose jurisdiction the OSA operates.
Registration Form:	is the Club registration form or that provided by the OSA.
The Player:	is the player named on this form.
The Team:	is the team indicated on this form.
The Club:	is the organization operating the teams and which is responsible for registering the players and placing them on teams (PYSC).
Club Registrar:	is the person authorized by the Club to register the players with the OSA and for submitting the player lists to the District Association for validation.
The District Association:	is the organization with which the Club is affiliated and which is responsible for the validation of this form – East Central Ontario Soccer Association.
District Registrar:	is the person authorized by the District Association to oversee player registration and who is responsible for validation of this form.

- 1.2. The player named on this form is registered only after the form has been properly completed, signed by the player, or guardian, accepted by the Club Registrar, and registration data entered into the OSA database. It is the responsibility of the Club to ensure that the player does not play before the "effective date" of his/her registration.
- 1.3. Registration with the OSA entitles a player to play for the team against another registered team in an exhibition, league, cup or tournament game one day after validation of the registration, provided the game is sanctioned by the OSA, and providing the data is entered into the OSA database.
- 1.4. As the information on this form is entered into a computer database, it is imperative that all the information is legible. Enter the information in the spaces defined for the data.
- 1.5. The Club registration identity is added by the Club to the database entry.

2. SEASON YEAR

Registration for outdoor soccer is for the calendar year in which the player is registering.

3. PLAYER DETAILS

- 3.1. The Club will register players using its OSA Registration number.
- 3.2. The player's birth date, gender, and previous last name, if the last name has changed, must be provided. The Ontario Health Card number can be added (optional).
- 3.3. The player's first name, middle name or initial and last name must be provided.
- 3.4. The player address, postal code, and telephone number must be provided. Fax number and e-mail address are optional. If the player lives outside the district at the time of registration, the current address must be provided.
- 3.5. Proof of birth date is to be provided by the player if requested by the Club.
- 3.6. An outdoor youth player cannot exceed the stipulated age category before January 1st of the current outdoor season.

4. TEAM DETAILS

- 4.1. Players registered with the PYSC shall be registered with the Club Registration Number and Club name.
- 4.2. Teams registered with the Club shall be registered with the OSA as Outdoor Youth Recreational – YR, or Mini-Soccer Recreational – MR, and identified by appropriate division.

5. CLUB LAST REGISTERED WITH

- 5.1. Providing this information (ie. Club, country, year) is mandatory.
- 5.2. Any person who provides false information or withholds any of the required information shall be suspended from soccer activities for one year.

6. FAILURE TO PROVIDE INFORMATION

- 6.1. The information required on this form must be provided or the registration will not be validated.
- 6.2. Any person who provides false information or withholds any of the required information shall be suspended from soccer activities for one year.

7. PLAYER SIGNATURE

The player or guardian signs the form acknowledging having read the registration requirements. The Club has been provided with the Constitution and the Published Rules of the OSA.

8. OTHER REQUIREMENTS

- 8.1. A player 14 years of age or older who was last registered in another country requires an International Transfer before registering.
- 8.2. Any player suspended from all soccer activities may not register.

9. CLUB REGISTRAR'S SIGNATURE

The Club Registrar must sign and date the registration. This signature is implicit in entry of the data into the OSA database. Signing the registration binds the Club to all OSA registration rules for this player. Failure to meet this requirement results in disciplining for non-compliance.
